T20 associated event - Thursday 22 April 2021

The Workshop is intended as an occasion to broaden participation in the Task Force (TF) “Climate Change, Sustainable Energy and Environment”: TF members present preliminary findings to be discussed by international experts, civil servants, and representatives of the private sector, who are also given the opportunity to provide new ideas, views and proposals.

The T20 Secretariat will collect all these inputs to enrich the final outcome of the T20 Italy.

This event is specifically devoted to the crucial G20 topic of global green recovery, with a focus on Asian perspectives and prospects. In particular, the Workshop is structured around two sessions: the first focuses on green finance as a tool to facilitate mobilisation of public and private capitals towards environmentally sustainable projects; the second one looks at different players’ commitments to the “net-zero emissions” goal, comparing and analysing plans to reach carbon neutrality over the next decades.
